

# Significant events for the Group in Half-Year 2025









### **51.7** M€ in S1 2025 (vs. 56.0 M€)

- Operating income: -2.7 M€ Consolidated net income at -3.6 M€
- Group turnover declined 8% in the first half of 2025 due to disruption in the US market (North American turnover down 20%).
- Accounting gross profit margin came in 6 percentage points lower YoY due to the impact of import tariffs and a less favorable "product mix".
- The net financial expense of €2.0 million included a €1.7 million unrealized loss linked to the decline in the valuation of the portfolio of Ubisoft Entertainment S.A. shares.

- Optimization of manufacturing and logistics to adapt to changing tariff environnement





#### Mid-Year Strategic Update - 2025

In 2025, the Group set out to adapt its strategic plan to meet evolving market dynamics, shifting consumer behaviors, and emerging geopolitical challenges.

As we reach the mid-point of the year, we remain committed to these objectives and continue to focus on:

- New competitive consumer product line to respond to market changes
  - T98 competitiveness: €99.99 and \$119.99
- **Diversification of production locations** to enhance resilience and flexibility
- Accelerating direct-to-consumer sales through the expansion of our eShops and the opening of new
   Marketplaces









- The T598, our latest Racing innovation, has been successfully ramped up. It continues to receive outstanding feedback from both the specialized press and the general public, confirming its strong market debut.
- Racing Product Line Renewal: A significant portion of our Racing steering wheel lineup was successfully renewed, allowing us to maintain a strategic positioning through our distributors. This renewal has secured stronger shelf presence and visibility, ensuring a solid foundation for future growth.
- Expansion of the Flying Range: We successfully launched our Sol-R range, marking the beginning of a new modular ecosystem built around the SOL-R base. This new foundation supports interchangeable handles (F-16, F-18 series), offering enhanced flexibility and customization for space and flight simulation enthusiasts. Building on this momentum, we are preparing the launch of our HOTAS configuration, further expanding the ecosystem.
- The Hercules DJControl Mix Ultra saw a successful launch in partnership with Guitar Center in the U.S., leading to expanded listings. This success has also opened new opportunities in the consumer DJ market in Japan and China.









#### One more thing! (or two)

















The Group's racing wheels are breaking new ground in their categories and are very well positioned commercially. In flight sim, the *Sol-R* range, launched in the spring, is set to be expanded and will help consolidate the Group's leading position in flight sim accessories.

The Group confirms its full-year 2025 forecast — upgraded at the end of July — of turnover in excess of €120 million and a net operating profit.
